

Notification

The Governor Himachal Pradesh is pleased to make the following amendments in guidelines pertaining to holding Jan Manch and the same will come into force immediately:

1. It has been decided that once the complaints are settled by the Departments, they will write to the complainants about the settlement of complaints through an official letter;
2. Hon'ble Ministers presiding over Jan Manch will submit a list of issues requiring follow-up at the Government level to the Chief Secretary;
3. A documentary will be prepared highlighting the major complaints disposed off and relief given to the complainants. Information and Public Relation Department will get this documentary prepared and Rural Development Department will prepare a list of such complaints disposed off for documentation;
4. Chief Secretary will conduct a video conference on Jan Manch every month;
5. Local MLAs will be requested to participate in Pre-Jan Manch programmes to get maximum benefit due to the mobilisation done during the Pre-Jan Manch;
6. SDMs will be Nodal Officers for Jan Manch and they will present a report on works done within 15 days prior to Jan Manch. ADC/ADM will coordinate holding of Jan Manch at the district level. One person will allow to submit only two complaints in the Jan Manch;
