Guidelines for the conduct of Government servant during elections.

Sir/Madam,

It is intimated that various complaints are being received in this department that some Government servants of the State Govt. are participating directly and indirectly in political activities and airing their views on various platforms of social media.

In this regard, your attention is invited to Rule-5 of Central Civil Services(Conduct) Rules, 1964, which debars a Govt. servant from taking part in any political activity in whatsoever manner except exercise of his right to vote as a citizen.

The provisions of Section-129(Officers etc, at elections not to act for candidate or to influence voting), 134 (Breaches of official duty in connection with election) and 134-A(Penalty for Govt. servant for acting as election agent, polling agent or counting agent) of the Representation of People Act, 1951 may also be brought to the notice of all Govt. servant for their guidance during Lok Sabha Elections, 2019.

All Govt. Servants under your administrative control including all Boards, Corporations, Universities and other Autonomous Bodies may be immediately informed of aforesaid legal provisions relating to conduct of Govt. servant during elections.
