**Notification**

The Governor Himachal Pradesh is pleased to make the following amendment in guidelines pertaining to holding the Jan Manch issued vide letter No. Per(AR)F(2)-1/2018 dated 17.05.2018 and 12.06.2018:

1. It has been noticed that all visitors participating in the Jan Manch do not necessarily visit the stalls put up by the Departments propagating their schemes. After detailed deliberations in the Council of Ministers, it was decided that it will be appropriate if the Departments putting up their stalls for exhibition during Jan Manch are asked to make a presentation about the schemes on display in their stalls and make detailed description of new initiatives pertaining to their Departments. This could be done before the arrival of the Chief Guest or immediately on the arrival of the Chief Guest.
2. It was decided that Superintending Engineers or their equivalent known by the name of Deputy Chief Engineers of all Departments will also attend Jan Manch every time, it is held.
3. A review meeting on implementation of pending complaints lodged in the Jan Manch will be taken by the Chief Secretary in which all Administrative Secretaries, Head of Departments and Deputy Commissioners will participate.
4. Hon'ble Ministers will review disposal of complaints pertaining to their Departments on monthly basis.

5. All Administrative Secretaries and all Heads of Departments will review disposal of complaints lodged during Jan Manch, using review meetings taken by them for review of performance in their programmes.



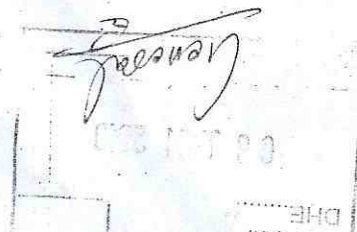


