**“Notification”**

In supersession of Notification EDN-A Ka (4) 6/98 dated 5<sup>th</sup> March, 2001 and subsequent Notification of even number dated 24<sup>th</sup> November, 2001 of the Department, the Governor, Himachal Pradesh is pleased to order to notify the guideline of Dr. Ambedkar Medhavi Dhhatra Yojana in the following manner:-

1. The Scholarship shall be given to first 10000 meritorious students from SC and 1000 from OBC category, strictly on merit basis as per merit list of Matric supplied by the H.P. Board of School Education Dharmshala, who secured 72% marks and in Matric examination.
2. He/She should belong to the category declared as schedule caste or other backward class by the H.P. Govt.
3. Under this scheme an amount of 10,000/-P.A. will be paid per student.
4. The scholarship shall be given in the +2 class also at the same rate to the first 1000/- meritorious student of SC and first 1000/- of OBC category, strictly on dthe merit basis as per the merit list of +1 class supplied by the H.P. Board of School Education Dharmshala, Kangra, H.P.
5. **Those students who secured 72% marks and above in matriculation examination held by H.P.Board of School Educaton Dharmshala, Kangra and take admission in any professional /technical courses in Govt./private institution approved by H.P. will also be eligible for the award of fresh./ one scholarship on the marit basis of matriculation examination.**
6. In case of any dispute the decision of the Director of Education H.P. will be final.
7. The eligible students will apply on the prescribed proforma along with Caste/Matric/+1/Himachal, Bonafide Certificate, whichever is applicable to their Heads of Institution by 15<sup>th</sup> Sept. of each year. The Head of institution will then forwarded there to the Deputy Director of Education. Deputy Director of Education will compil list of his Distt. And submitted to Directorate of Education on or before 15<sup>th</sup> Oct. each year
