Sir,

I am directed to invite your kind attention to this Department's letter No.Fin(Pen)A(3)-5/2006-Vol.-IV dated 12-08-2015 and No.Fin(Pen)F(4)-1/2015 dated 9th June, 2016 on the subject cited above and to say that the Government of Himachal Pradesh in Budget Speech for the Financial Year 2017-18 has decided to increase the upper ceiling of the Government co-contribution from Rs. 1,000/- to Rs. 2,000/- per subscriber under the Atal Pension Yojana. For this purpose, a budget provision of ₹ 10/- Crore has been made for the above Financial Year-2017-18. It is once again made clear that the Govt. co-contribution under the Atal Pension Yojana will be admissible to only those un-organised Sector Workers in Himachal Pradesh who are neither member(s) of any Social Security Scheme nor are income Tax payees and they have opened their bank accounts in the State.

You are therefore, requested to ensure maximum coverage of unorganized sector workers, viz. MGNREGA Workers, Farmers, Agricultural and Horticultural Labourers, Shop Workers, Anganwari Workers and Mid-Day Meal Workers etc. in the State. Besides above, earnest efforts may be made to popularize the Atal Pension Yojana in the State and the co-contribution being made by the Himachal Pradesh Government to this Yojana.
