It is stated that the memorandum of losses due to flash floods, cloud bursts & landslides is being prepared by the Govt. which is required to be submitted to the Govt. of India, Ministry of Home Affairs shortly. Public representative/functionaries frequently mention about large number of losses in their area and seek funds for restoration activities. The Govt. has pointed out that losses incurred are not being assessed at ground level and no reports are being sent to Govt. in stipulated period.

The cases of losses due to flash floods, cloud bursts & landslides may be taken up with concerned Deputy Commission for providing of funds through SDRF/NDRF, under intimation to this Directorate.
