<b>1. Last date of submission of forms by students in schools to the heads of the respective institutions</b>	<b>15th August</b>
<b>2. Last date of submission of application forms (in consolidated form) from schools to the Deputy Director of Higher Education .Forms of each category of Scholarship Scheme should be sent by hand through a messenger/ office clerk to the concerned Deputy Director of Higher Education.</b>	<b>15th September</b>
<b>3. Last date of submission of application forms (after proper scrutiny and in consolidated form)by the Deputy Director of Higher Education to the Directorate of Higher Education through a special messenger. The application forms should be consolidated category –wise/scheme-wise in the soft copy and hard copy.</b>	<b>15th October</b>
<b>4. Last date of submission of eligible Students list from colleges (as per proforma) &amp; requirement of Budget from Directorate of Higher Education.</b>	<b>15th October</b>
<b>5. Last date of submission of scholarship forms from H.P. University, out of State to Directorate of Higher Education.</b>	<b>30th October</b>
