Regarding non-participation of School Librarians/Assistant Librarians of Six Districts (One Week In-Service-Training Programme Capacity Building: Library Management) at Government College of Teacher Education Kangra at Dharamshala, District Kangra, Himachal Pradesh from 11.02.2019 to 16.02.2019.

It has brought to the notice of undersigned by the Principal, Government College of Teacher Education Kangra at Dharamshala, District Kangra, Himachal Pradesh that One Week In-Service-Training Programme (Capacity Building: Library Management) was organized for School Librarians/Assistant Librarians of Six Districts from 11.02.2019 to 16.02.2019 at GCTE Dharamshala. 60 participants were invited from six Districts to attend the above said programme (10 participants from each district). But only 30 candidates participated in the training programme and rest of candidates did not bother to attend the programme. It seems that they are not bothered to obey the orders of the higher authorities, which amounts to misconduct/unbecoming behavior on their part.

You are, therefore hereby directed to motivate the teaching and non-teaching staff to attend each training programme/seminar/conference etc. in future as the Department of Higher Education has to achieve target fixed by the Government in Result Frame Document and training is an important component and lackadaisical approach shall not be tolerated.

Further, you are directed to take disciplinary action against those School Librarians/Assistant Librarians who have not attended above said programme at G.C.T.E. Dharamshala and send the action taken report to this Directorate within a week so that further necessary action can be taken in the matter accordingly.


