

In this connection, it is to inform you that the Hon'ble Chief Minister
of Himachal Pradesh has announced a scheme in this budget speech that Sanitary Napkins
which are essential to personal Hygiene for adolescent girls shall be provided to all the girls
studying in schools up to 10+2 level at the cost of Rs.1 per packet. You are, therefore directed
to direct the head of institutions to identify one Nodal officer amongst the teachers and send
the list of Nodal teacher Officers to Chief Medical Officer of your direct within a week.


These Nodal Teachers will be responsible for receiving storage,
distribution and documentation of the Sanitary Napkins. The ASHA workers will go to their
designated schools once in a quarter, to collect the information on the reporting format given
by the State headquarter.
