OFFICE ORDER

In pursuance of the decision taken by the Govt. for taking over of the services of 95% aided employees of privately managed Public Sr.Sec.School Indpur Distt. Kangra as conveyed by the Addl. Chief Secretary (Education) to the Govt. of Himachal Pradesh vide Notification No Shiksha-II-Chha(10)-8/2011-III dated 15.06.2017 the services of the following PGT against the post shown in column No.2 of following table is hereby taken over with immediate effect on regular basis in the pay structure of Rs.10300-34800+4200 GP in terms of policy framed with terms and conditions of taking over, vide letter No. Shiksha-II-Chha(10)-8/2011(date 20.7.2017). The appointee is directed to report for duty in the respective school of his/her posting as shown against his/her name within the prescribed time subject to the acceptance and fulfillment of the following specific terms and conditions:-

Terms and conditions.

1. The services of these PGT are taken over as a fresh appointment on regular basis on minimum of pay scale of the post. However, their pay has to be protected as a measure personal to them in terms of policy. The past services will not be counted for any other intent and purpose i.e. seniority/pensionary benefits/leave etc. They will be placed at the bottom of the seniority of the cadre. The services will be considered against the direct quota.
2. It will be the personal responsibility of the Principal to inform this Directorate regarding joining of the concerned PGT.
3. That the educational and professional qualifications possessed by the candidate will be the same as prescribed by the Department for the post of PGT in the concerned group (Subject). The Head of the school will also ensure that the educational and professional qualification possessed by the candidate is from a recognized University. All necessary verification to this effect is to be made by the Head of the concerned school at the time of his/her joining. Duly attested copies of certificates be kept in the Office for record.
4. The candidate belonging to schedule caste/ schedule tribe/OBC classes will furnish the requisite certificates on prescribe proforma duly issued by the competent authority.
5. Every employee shall have to serve at least one term in the Tribal/Difficult areas subject to adequate number of post(s) available in such area. If posted in non Tribal /Non-Difficult he shall be posted at any time in Tribal / Difficult areas as per need of the Department in relaxation of all terms and conditions.
6. Candidate will have to submit a certificate of his/her fitness from a Government Medical Officer. Women candidate pregnant beyond 12 weeks will stand temporarily unfit till the confinement is over. The women candidate will be re-examined for the fitness from an Government Medical Officer.
7. PGTs shall teach those subjects from class 6th to 10th which they had studied at the Graduation level, in addition to teaching of plus one and two classes of the subjects studied by them at the

(Post-Graduation Level), to enable them to full fill the minimum norms of teaching per week. Provided that they shall not be paid salaries for the month to which they have not completed minimum norms of teaching per week.

8. No TA/DA will be allowed to join the post.
9. He/She Will have to give a declaration to the effect that He/She has only living spouse if married.
10. He/She will have to take an oath of allegiance /faithfulness to the constitution of India or making solemn affirmation.
11. **The candidate(s) must be bonafied of Himachal Pradesh.**

If these specific as well as usual terms and conditions are acceptable to the candidate(s), he/she will report for duty at the institution of his posting within the period of 20 days from the date of issue of these orders along with documents required to be produced as per terms of this order.
