



As you are aware that HIV is driven by number of socio-economic factors, therefore, health interventions alone are not sufficient to address the cause and consequences of the epidemic. It requires a multi-sectoral response. Mainstreaming approaches to HIV have increasingly gained ground with the realization that the non-health sector can play an important and meaningful role in reducing vulnerability to HIV and mitigation its impact on those infected and affected.

As far as HIV vulnerability is concerned, India has the 3rd largest number of People Living with HIV in the world i.e. 21 lakh (HSS 2012-13 data) and 8853 cases of HIV have been detected in Himachal Pradesh till March 2016 out of these 3335 cases are getting Anti-Retroviral Therapy.

Also, India is working on goal to end AIDS by 2030 and one foremost ambitious target for this is 90:90:90, which is set to be achieved by 2020. First 90 is 90% of all people living with HIV will know their HIV status, second is 90% of all people with diagnosed HIV infection will receive sustained antiretroviral therapy and third is 90% of all people receiving antiretroviral therapy will have viral suppression. Awareness in terms of correct knowledge and motivation to utilize services available is the major component to achieve these goals/targets. Mainstreaming approach i.e. involving all departments and organizations to create awareness web is key strategy to achieve this.

In this regard, Higher Education Department is very important partner in fight to end AIDS. I am grateful to you and your Department for providing support for World AIDS Day, implementation of Red Ribbon Clubs and many other activities. Further, one major activity of Higher Education Department is Youth festival where all colleges and schools are associated and large numbers of students are involved. Integration of topics related to HIV in this activity will be very useful and message will percolate down the line to large numbers of youth students in innovative way.
