Objectives of the State Level Quality Assurance Body will be:-

- (i) Endeavour to enhance quality assurance by creating awareness and sustainable quality assurance.
- (ii) To draw up state-level action plan in consultation with NAAC.
- (iii) Act as nodal agency/ies between the respective state HEIs and the NAAC.
- (iv) To conduct awareness programmes on issues related to quality assurance.
- (v) To motivate colleges and other HEIs of the state to undergo assessment and accreditation, based on a phase-wise plan, prepared in consultation with NAAC.
- (vi) To assist the NAAC in initiating post-accreditation quality sustenance measures in the state.
- (vii) To advice the state government to initiate suitable measures for ascertaining the maintenance of minimum standards in HEIs.
- (viii) To advice the NAAC on the quality assurance activities to be taken up by the HEIs in the state, for achieving globally acceptable standards.
