

NOTIFICATION

The Governor, Himachal Pradesh is please to institute an Incentive/Award named as "Atal Protsahan Yojna" for all those students of the State who are selected and take admission for a degree course in any Indian Institutes of Technology [IITs] or All India Institute of Medical Sciences [AIIMS] and for a Post Graduate Diploma Course in any Indian Institute of Management [IIMs]. The scheme shall come into force w.e.f. current financial year i.e. financial year 2012-13. The guidelines for regulation/implementation of scholarship scheme are as under:

1. A one time Incentive/Award of Rs. 31,000/- [Thirty One Thousands] will be given to all those students of the State who are selected and take admission for a degree course in any Indian Institutes of Technology [IIT] or All India Institute of Medical Sciences [AIIMS] and for a Post Graduate Diploma Course in any Indian Institute of Management [IIMs].
2. All the eligible students will have to apply on the prescribed proforma along with Selection/Admission proof directly to Director of Higher Education.
3. In case of any dispute, the Director, [Hr. Education] will decide all the matter/issues, immediately. However, any person aggrieved with the decision of Director [Hr. Education], may file an appeal before the Secretary [Education] to the Government of H.P. within 45 days of decision.
