

Sir,

It is brought to your kind notice that the matter regarding grant of permanent affiliation to those Govt. Colleges who have completed five years of temporary/provisional affiliation and are eligible to seek permanent affiliation in view of the provisions of the regulations has been engaging the attention of the University as well as the State Government as these Colleges requisite Permanent affiliation certificate from the University for seeking grants/assistance from UGC on the basis of their NAAC inspection. The matter has now been examined at the level of the University and it has been decided that such Govt. Colleges can be issued Permanent affiliation certificates in case they fulfil the prescribed conditions of the regulation.

Further, it has been decided that all Govt. Colleges may be directed to submit the proposal on the prescribed proforma alongwith requisite fee for granting permanent affiliation, if otherwise eligible.

You are, therefore, requested to kindly direct all the Govt Colleges in this regard.
