Sir/Madam,

I am directed to invite your kind attention to the subject cited above and to say that for time bound delivery of public services and as mandated under Public Service Guarantee Act, 2011, 185 services of 25 (twenty five) departments i.e. Agr, AH, Coop, E,S&T, Forest, Health, Home (fire), Home (police), Housing, Industries, I&PH, PR, Revenue, SJ&E, T&CP, Transport, UD, Labour & Employment, Horticulture, Pollution Control Board, Ayurveda, PWD, HPSEBoard, MPP&Power, F&CS have been identified/notified under this Act. However, many services being provided by other departments have still not been identified and notified as yet, such services are essentially required to be identified/notified under the Act for the speedy & timely disposal of these services.
