<p><b>Note:</b> - Admission is open for all students on Roll on Basis, who are otherwise eligible without waiting for the final result. <u>Roll On system means the student who has appeared in the 1<sup>st</sup>/3<sup>rd</sup> &amp; 5<sup>th</sup> Semester will go to the 2<sup>nd</sup>/ 4<sup>th</sup> &amp; 6<sup>th</sup> Semester as per the schedule without waiting for the result of the 1<sup>st</sup>/3<sup>rd</sup> &amp; 5<sup>th</sup> Semester. However, he/she will have to fulfill all the formalities laid down by the college authorities like filling up of the admission form, if any, and depositing the prescribed fees. This will help to start the regular teaching of 2<sup>nd</sup>/4<sup>th</sup> &amp; 6<sup>th</sup> Semester in time.</u></p>			

Principal may ensure that there is no provision of admission as per university ordinance after 30<sup>th</sup> June of every year and as per Hon'ble High Court Decision, no admission will be given after the schedule. Principal concerned will be responsible for strict compliance of the admission schedule.
