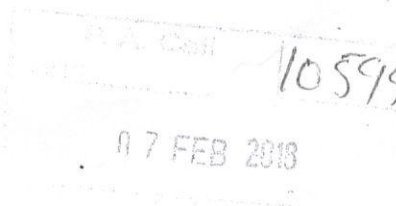
1. on compassionate grounds,


