Adjustment of PTWCs/Water Carriers-cum-Peon on daily wages basis on promotion
as Peon (Class-IV)

Sir,

I am directed to refer to the subject cited above and to say that approval regarding regularization of PTWCs/Water Carriers-cum-Peon(daily wages basis) of Higher/Elementary Education appointed under 1996 and 2001 policy, who have rendered 14 years continuous service as PTWC or PTWC and Water Carrier-cum-Peon on daily wages basis(combined) till 31/03/2016 and 30/09/2016 or shall complete 14 years continuous service on the same dates of subsequent years as Peon(Class-IV) against available vacancies of Peon(Class-IV) in Education Department perceptively throughout the state was conveyed vide this department letter of even number dated 23/02/2017.

Thereafter the matter came to the notice that available posts in the Education Department against which the regularization is to be made are less then requirement. The matter was taken up with Finance Department, which has observed that in view of need of for economy and the fact that if these persons are adjusted in other Departments Class-IV vacancies, then the demand of other Department to fill up their Class-IV posts will be met with.

The Finance Department has further approved that in view of unavailability of sufficient vacancies of Class-IV in Education Department, Department may consider adjustment of remaining 1434 posts of Daily Wage Water Carriers/Water Carriers-cum-Peon presently on daily wages, for regularization against vacancies in the other departments such as Health, Animal Husbandry, Agriculture, Horticulture, Technical Education and Irrigation of Public Health in their respect districts by Deputy Directors and concerned Department of the districts subject to completion of all codal formalities.

It is therefore, requested that all Deputy Directors (Higher Education) in the districts be directed to get the details of class -IV vacancies in Health, Animal Husbandry, Agriculture, I&PH, Horticulture and Technical Education as per the requirement and issue orders for the regularization of PTWC presently working on daily wages basis against those vacancies, immediately, **but not later than one month**, as per the approval of Finance Department.
